Jim Cleaver attended a meeting during the year of PACTT (Planning the ACT Together) held at Hughes. 3 LAPAC. Rod thanked Audrey Horridge YRA's representative on the Burley Griffin LAPAC which covers the suburbs of Yarralumla, Deakin, Hughes and Garran. 4 Energy Efficiency Ratings. Rod handed over to Jim Cleaver who gave an informative talk explaining the government's new compulsory Energy Efficiency Ratings which will apply when selling all homes as from 24 December 1998. YRA TREASURER'S REPORT:

GUEST SPEAKERS:

Susan Conroy, Ross Burden and Paul Bombadier from Yarralumla Precinct Management Group (Dept Urban Services) addressed the meeting about and with maps of the upgrading of the Yarralumla Shopping Centre surrounds. Main issues addressed were; parking, traffic flow, amenities, lighting. Meeting raised additional issues; Bentham Street one way, delineated parking spaces, zebra crossing, problem of graffiti on proposed toilet block mural, long stay parking for employees of businesses and shops, parking in surrounding streets, steps and the elderly, toilet block internal upgrade. The meeting expressed its gratitude to Susan Conroy, Ross Burden and Paul Bombadier.

OTHER BUSINESS:

The following matters were canvassed by the meeting. The side effects of dual occupancy, ie additional cars parked in street, infrastructure, etc. Rod Page advised LAPAC appropriate body for dual occupancy problems and although LAPACs have no input into this area at present they want a voice. Agreed some large double storey homes on small blocks are equally a problem. Jim Cleaver advised legislation soon to be enacted will allow anyone a comment on developments.

Rod Page moved a vote of thanks to the Reverend Ken Jarvis for the use of the Uniting Church Hall.
